Sealed proposals will be received and considered by the Town Board of the Town of Cheektowaga on March 22, 2017 at 11:00 am, at the Town Hall, corner of Broadway and Union Roads, Cheektowaga, New York for the Cold Milling of Various Town Highways in the Town of Cheektowaga for the calendar year 2017.

Information for bidders and specifications may be obtained from the Town Clerk at her office in said Town.

Proposals shall be submitted in a sealed envelope, plainly marked on the outside "Bid for Cold Milling of Various Town Highways" and submitted to the Town Clerk prior to bid opening.

No bidder may withdraw his bid within forty-five (45) days after the actual date of the opening thereof.
